## Minutes of the Argos Community Schools Regular School Board Meeting Held on May 18, 2020

The Board of School Trustees held a regular and virtual school board meeting on May 18, 2020. The following individuals were present for all or a part of the meeting.

Monty Peden called the meeting to order, led the Pledge of Allegiance and moment of silence at 7:06 p.m.

No patron comments were heard.

Jennifer Hurford made a motion to approve the minutes of the April 20, 2020 Regular Board and Executive Session meetings. Jennifer Porter seconded the motion and the motion passed 5-0.

Angela Smith made a motion to approve 2020-2021 meal prices as presented to the Board. These would be as follows:

Jennifer Hurford seconded the motion and the motion passed 5-0.

Jennifer Hurford made a motion to approve Nick Medich as Athletic Director and Andy Stone and Kelli Van Der Weele as Athletic Coordinators. Jennifer Porter seconded the motion and the motion was approved 5-0.

Mr. Speicher asked the Board for approval of Administration and Director contracts as presented. Angela Smith made a motion to approve with a second by Jennifer Porter. The motion was approved 5-0.

Mr. Speicher asked the Board for approval of a wage increase for classified staff members who receive either an effective or highly effective evaluation. This increase of 1-½% for an effective evaluation and 2% for a highly effective evaluation would go into effect for those staff members for the 2020-2021 school year. This increase would not be received by any staff receiving an evaluation of "needs improvement" or "ineffective". After discussion, Jennifer Porter made a motion to approve all wage increases as discussed with a second by Chris O'Dell. The motion passed 5-0.

Mr. Speicher presented the Board with the 2020-2021 Educational Material Fees. Fees will not increase for the upcoming school year and will be as follows: Grades K-2 \$180.00, Grades 3-5 \$195.00, Grades 6-8 \$195.00 and Grades 9-12 \$220.00 with the addition of AP and dual credit course fees added per enrolled class. Chris O'Dell made a motion to approve these fees as presented. Angela Smith seconded the motion and the motion passed 5-0.

Jennifer Porter made a motion to approve the 2020-2021 student handbook. Jennifer Hurford seconded the motion and the motion passed 5-0.

The Board received all 2020-2021 handbooks and summaries of changes proposed for the classified employee, certified employee and substitute handbooks for review. After discussion Angela Smith made a motion to approve all handbooks as presented with a second by Chris O'Dell. The motion passed 5-0.

Mr. Speicher's Instructional Report reviewed the Special Education Joint Services Agreement. After discussion Jennifer Hurford made a motion to approve with a second by Jennifer Porter. The motion passed 5-0.

The Construction Report presented by Mr. Speicher included an update on the solar project and he presented the Board with a Power Purchase Agreement. After discussion Chris O'Dell made a motion to approve the agreement with a second by Jennifer Porter. The motion passed 5-0. The Energy Savings Project Pay Application #5 for \$709,985.00 was presented. Angela Smith made a motion to approve payment with a second by Jennifer Hurford. The motion passed 5-0. Mr. Speicher presented the Board with a review of summer construction projects which include the painting of classrooms as needed and upgrades to the media center. Jennifer Porter made a motion to approve these projects with a second by Angela Smith. The motion passed 5-0.

Monty Peden recognized and thanked individuals and businesses for donations received per the attached listing. Jennifer Hurford made a motion to approve with a second by Chris O'Dell. The motion passed 5-0.

Jennifer Lee presented the Board with claims for the month of April totaling \$471,047.61. These claims included accounts payable and payroll. Chris O'Dell made a motion to approve with a second by Jennifer Porter. The motion passed 5-0.

Mr. Speicher presented the Financial Report to the Board.

Closing comments were heard by Mr. Speicher and Board members and having no other items for discussion, Jennifer Porter made a motion to adjourn with a second by Chris O'Dell. The motion passed 5-0 and the meeting was adjourned at 8:35 p.m.
