Monty Peden called the meeting to order, led the Pledge of Allegiance and moment of silence at 7:08 p.m.

Jennifer Hurford made a motion to approve the minutes of the October 12, 2020 Public Hearing and Regular board meetings. Jennifer Porter seconded the motion and the motion passed 4-0.

Angela Smith made a motion to approve all Personnel changes per the attached listing. Jennifer Hurford seconded the motion and the motion passed unanimously.

Jennifer Porter made a motion to set January 11, 2021 as the date for the reorganization meeting and regular board meeting. Jennifer Hurford seconded the motion and the motion passed 4-0.

Mr. Speicher presented the Financial Report to the Board. Jennifer Porter made a motion to approve up to \$200,000 from the operations fund to the rainy day fund from the 2020 budget. Angela Smith seconded the motion and the motion passed 4-0. Jennifer Hurford made a motion

to approve up to \$250,000 from the educational fund to the rainy day fund from the 2020 budget. Jennifer Porter seconded the motion and the motion passed unanimously.

Mr. Speicher presented the Go Solutions contract for Board consideration and approval. Jennifer Hurford made a motion to approve with a second from Angela Smith. The motion passed 4-0.

Angela Smith made a motion to approve the TAG Grant and payment to certified staff. Jennifer Porter seconded the motion and the motion passed unanimously.

Jennifer Hurford presented to the Board consideration of the additional days worked by Mr. Speicher due to the COVID crisis. Mr. Speicher's current contract is based on a 3-4 day/week schedule. Additional days have been needed since March due to the COVID crisis. She asked that the Board approve these 32 additional days for the period of March - December 31, 2020, to be paid at the current daily rate. Monty Peden seconded the motion and the motion passed unanimously.

Mr. Speicher presented to the Board an overview of the Argos Childcare Academy which would be housed in the former Administration building. Jennifer Porter made a motion to approve with a second by Jennifer Hurford. The motion passed 4-0.

Mr. Speicher reviewed the memorandum of understanding with Small Wonders Daycare to operate the Argos Childcare Academy. After discussion Angela Smith made a motion to approve with a second by Jennifer Porter. The motion passed 4-0.

Mr. Speicher reviewed the proposed irrigation system for the soccer practice fields. He expects to receive a quote to present to the Board at the next meeting. He asked the Board to consider the approval of Halo vape detectors for Jr.-Sr. High restroom facilities. After discussion Jennifer Hurford made a motion to approve with a second by Angela Smith. The motion passed 4-0.

Mr. Speicher's Instructional Report reviewed attendance and quarantine/isolation reports, an enrollment report, fall extracurricular awards and winter extracurricular activities, protocols and attendance.

Monty Peden recognized and thanked individuals and businesses for donations received per the attached listing. Jennifer Hurford made a motion to approve with a second by Jennifer Porter. The motion passed 4-0. Jennifer Lee presented the Board with claims for the month of October totaling \$586,039.92. These claims included accounts payable and payroll. Jennifer Hurford made a motion to approve with a second from Angela Smith. The motion passed unanimously.

Closing comments were heard and having no other items for discussion, Jennifer Hurford made a motion to adjourn with a second by Jennifer Porter. The motion passed 4-0 and the meeting was adjourned at 8:05 p.m.
