Board Member Karra Duff was absent. Board President Angela Smith called the meeting to order at 6:04 p.m. and led the Pledge of Allegiance and moment of silence.

There was no communication from patrons.

Jennifer Hurford made a motion to approve the minutes of the June 20, 2022 regular Board Meeting. Chris O'Dell seconded the motion and the motion passed 4-0.

Pat Rensberger made a motion to accept all personnel changes, per the attached listing. Jennifer Hurford seconded the motion and the motion passed 4-0.

updated the Board on the Alternative Program. We will be using Edmentum for this program as well as for our credit recovery. A location is being finalized and more information will be coming.

Jennifer Lee presented the Board with claims totaling \$1,185,400.10 for AP, payroll and bond payments. Pat Rensberger made a motion to approve the claims with a second by Chris O'Dell. The motion passed 4-0.

Mr. Speicher reminded the Board that there will be a childhood immunization clinic at Back to School Night, on Monday, August 8, 2022. Masks are still optional, at this time, for the 2022-2023 school year. He also updated the Board on the school bus purchase. Our purchase order with Midwest Transit has been canceled due to the manufacturer no longer making that type of bus. We are currently looking at purchasing a fresh off of lease bus. Andy Stone will inspect the bus before any purchase is paid.

Having no other items for discussion, Chris O'Dell made a motion to adjourn with a second by Pat Rensberger. The motion passed 4-0 and the meeting was adjourned at 6:44 p.m..
